

Foundation regulations

Validity

The Foundation's regulations form an integral part of the contract between the parents and the Foundation in relation to the childcare place in one of the three children's homes. The regulations in German language are binding.

Opening hours

The children's houses are open from Monday 6.30 am to Friday 6.30 pm. The children's houses are closed on cantonal and federal holidays. The changed opening hours (before public holidays) can be found in our vacation leaflet. Our annual company vacations take place in the week between Christmas and New Year.

Childcare costs

The invoices for the childcare costs are sent by e-mail and must be paid using the QR code and the appropriate IBAN number; we recommend a standing order. The childcare place is always paid in advance for the following month. Any subsidies must be applied for directly from the city of Wetzikon. This requires a confirmation of place from the respective location.

A one-time administration fee of CHF 50 per child must be paid together with the first payment.

A deposit of CHF 250 must be paid for reservations made 6 months or more in advance. This will be refunded after admission.

Familiarization

The settling-in period takes place one month before the start of the contract and is agreed individually.

The settling-in period is charged by the hour. The price is CHF 15 per hour and child.

Cancelation

This contract can be cancelled with two months' notice to the end of the month.

Notice of cancellation must be given in writing to the childcare management or the management of the Foundation.

In the case of partial cancellation, the notice period of two months must also be observed.

If the contract or the registration is cancelled before the start of the contract, the notice period also applies. In the event of non-compliance, the months from the start of the contract during the notice period will be invoiced in accordance with the tariff list, even if the childcare is not used.

Illness and absence

A sick child may not be cared for in the children's homes due to the risk of infection. If a child cannot come to the Kinderhaus, he/she must be signed out by telephone by 9.30 am. If a child falls ill or is injured during the childcare period, parents will be informed immediately so that they can collect the child as soon as possible.

Parents are requested to notify us as soon as possible of any vacation absences. Absences of any kind, e.g., due to vacation, illness or accident, cannot be made up or refunded.

Vacation

If you are absent for more than 6 weeks at a time, you have the option of applying for a vacation. If your application is approved, you will pay a reservation fee of 50% of the normal rate during this time.

Re-entry without a reservation fee is possible for an absence of at least four months. Re-entry is based on the waiting list.

Medical emergency

The childcare staff are trained to deal with accidents in the children's homes.

They regularly attend the emergency first aid course for small children. We provide immediate first aid and act in the interests of the child involved in the accident.

The caregivers are authorized to take a child immediately to medical treatment or to the nearest hospital.

The parents are responsible for the child's general visits to the doctor.

Discount

When a sibling joins, the older child receives a 10% discount on the childcare costs.

Any swap days can only be included in the unannounced relationship and cannot be accumulated over the year.

Federal ordinance

If the childcare facility is temporarily closed by order of the federal government or another higher authority, the monthly flat rate remains payable. Any repayments made to us by the authorities will be reimbursed to you.

The foundation regulations are an integral part of the childcare contract and registration and become valid when the contract or the registration is signed.
